Major (Elective-1): World Politics 1919 to 1945 Credits 04

MJE-1T: World Politics 1919 to 1945

Course outcome: This course focuses on European History, beginning with the aftermath of the First World War, and finally provides a picture of Europe between the two World Wars. This paper examines key aspects of the twentieth-century World, highlighting the impact of a shift from Eurocentric to ideologically polarized superpower-centric politics, particularly during the Cold War. Students will also learn about the emergence of the Third World and the rise of a unipolar World system.

- IV. **Cold War and the emergence of bipolar politics:** Rise of Communist China; Cold War in Asia: Korea, Cuba, Vietnam, Middle East; Third World and Non-Aligned Movement; Détente and disintegration of the Soviet Bloc; Future of the Cold War

Course outcome: This course focuses on thoughts and views of great thinkers such as Bankim Chandra Chattopadhyay, Rabindranath Tagore and Swami Vivekananda who have shaped the educational scenario in India and the World. Students will learn about their philosophical theories on topics like liberty, justice, rights, authority and education which have paved the way for revolutions and changes in India as well as in the World.

Course Content:
